\*Hon'able National Company Law Tribunal, New Delhi vide its order dated February 01, 2021 has approved the Scheme of Amalgamation between RightMatch Holdings Limited ("RightMatch") and R Systems International Limited ("R Systems") and their respective Shareholders and Creditors ("Scheme").
